**Footnotes**

PARISH LAND set the pace along the rail under pressure into upper stretch and edged away under intermittent urging. CAUTIOUS CAT forced the pace outside the winner to the turn, but couldn't stay with that one while clearly best of the others. ENGAGE was carried six wide on the first turn, made a move four wide to threaten on the turn then finished evenly. ASKARA was unhurried early, split rivals while gaining on the turn, but couldn't sustain her rally. MISK saved ground while just off the pace into upper stretch and drifted out while tiring in the final eighth. RESORT gained a bit while behind horses on the turn and flattened out. TECHNICAL QUESTION checked along the inside on the first turn and failed to menace thereafter. CLEVER ACCOUNT chased three wide to the turn and gave way. SUNRISE SERVICE was finished early.
