Footnotes

SWING THE CAT (NZ) tracked the pace, swung to the outside leaving the turn, drifted in in early stretch impeding STARSHIP ELAINE, rallied to gain the lead just inside the eighth pole and was fully extended to prevail. PARISIAN AFFAIR chased the pace three wide, moved up to vie for lead on the turn and continued on with good courage for the place while being outfinished by the winner. STARSHIP ELAINE chased the pace, angled outside the leaders for the drive, was checked in behind SWING THE CAT in early stretch, then closed to gain the show. LA ASPERA (ARG) vied for the lead along the rail to past the eighth pole and gave way. MAIN STREAM rated off the pace, lacked a late response. LILLY'SOFTHEFIELD off slowly, failed to menace. NEVADA SUNRISE was outrun after stumbling at the start. BIKINI MOON vied for the lead outside LA ASPERA into the stretch and tired. FEIJOADA was not a factor after breaking slowly. Following a stewards inquiry and a claim of foul by the rider of STARSHIP ELAINE, SWING THE CAT was disqualified and placed third for interference to that rival in the stretch. (The rail on the turf course was set at 48 feet).
