PRESIOUS PASSION rated off the pace, angled out for the stretch run, then rallied to be up late and won going away. UNCA BUBBA allowed to settle, angled to the outside in the stretch and rallied to be up for the place while unable to stay with the winner. SPIKEAVELLIAN stalked the pace three wide, made a run to reach even terms for command inside the eighth pole but was outfinished. CREATIVE JIMMY a bit rank while reserved in the early going, split rivals in the stretch to reach near even terms for command, then weakened late. DECENT EXPOSURE set the pace along the rail to deep stretch and gave way. ZARA'S STORM failed to menace. THEATER REVIEW moved up to chase the pace after breaking slowly, made a run at the leader on the far turn and into the stretch, then tired. HENRY J C steadied in behind DECENT EXPOSURE in the early going and again on the backstretch, tracked that rival along the rail into the stretch, then faltered. MR. MYSTERY was no factor after being steadied at the start. RED CYPRESS off slowly, raced in striking position into the far turn and faded.
