Footnotes

SNAKE RIVER CANYON set the pace along the inside, responded when headed by DUCK HUNT, continued to make the pace into the stretch, then repulsed a bid from UNGI BLANC in deep stretch and was all out to just last over LEMON CUSTARD. The latter, unhurried early, swung out for the stretch run and rallied to just miss. UNGI BLANC stalked the pace three wide, angled to the inside in the stretch, made a run to reach SNAKE RIVER CANYON in deep stretch but was edged to the wire. ROMP (ARG) tracked the pace into the stretch and closed with a mild response. RUNNING WISH rated off the pace after bumping soundly with INVISIBLE GEORGE at the start, made a run four wide around the far turn to loom a threat in the stretch, then gave way. DUCK HUNT chased the pace, moved up to engage SNAKE RIVER CANYON racing down the backstretch, tried that rival to nearing the stretch, then tired. DISCREET CHARMER was not a factor. SANCTION up close early, saved ground and faltered. RUNNING APTITUDE reserved off the pace after bumping

with INVISIBLE GEORGE at the start, faded leaving the far turn. INVISIBLE GEORGE showed little after being squeezed back at the start.
