Footnotes

UNDER CONTROL (BRZ) rated off the pace, raced four wide around the far turn and rallied to be just up at the wire. HOLLINGER stalked the pace three wide into the stretch, then rallied to gain a brief lead nearing the wire and just failed to last. SOUTHERN PARKWAY unhurried early, swung out for the stretch run and rallied to just miss catching the top ones. BIG BLUE SPIRIT (GB) reserved after being steadied along the inside on the first turn losing position, rallied between rivals in the stretch to just miss the show. PERFECT TAY allowed to settle, rallied along the rail through the stretch while being outfinished. STORMBERG pressed the pace outside INCREDICAT to deep stretch and weakened. INCREDICAT set the pace under pressure along the inside, came out a bit under left-handed urging in the stretch and gave way late. MALIBU WAY taken in hand early, raced in striking position into the stretch, then steadied when caught in behind rivals in the stretch and failed to recover. TRICKY HAT (CHI) failed to menace. LOUKAS (IRE) chased the pace along the inside into the far turn and tired. THE RIDER OF MALIBU WAY LODGED AN OBJECTION AGAINST THE RIDERS OF UNDER CONTROL AND HOLLINGER FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIMS OF FOUL WERE NOT ALLOWED.
