Footnotes

CARS AND TRUCKS stalked the pace off the rail, moved to gain a slim lead leaving the far turn, then was all out to prevail. JARDUN rated off the pace, eased three wide on the far turn, then rallied to try CARS AND TRUCKS through the stretch but was outgamed to the wire. SOUP A' FLEET reserved off the pace, steadied in traffic on the first turn, swung out for the stretch run and rallied for the show. FIRST TRACKS (ARG) allowed to settle after breaking slowly, passed tired rivals along the inside in the drive. PACKERS VALLEY taken in hand to save ground, eased out while advancing to loom a threat in the stretch, then gave way. IT'S A SIN unhurried early, improved his position without threatening. FEAR NOTHING stalked the pace three wide, then bumped hard with

ROYAL JOKESTER at the top of the stretch and tired. NAMRON well placed, raced five wide around the far turn, then bumped hard with ROYAL JOKESTER at the top of the stretch and faltered. SUPERORITY set the pace along the inside to nearing the top of the stretch, then had nothing left. ROYAL JOKESTER chased the pace three wide, then was fading when bumped and steadied from between rivals at the top of the stretch. RED ZONE FLYER was outrun after hesitating at the start.
