Footnotes

LEMON DROP KID was carried wide on the first turn, raced just behind the leaders while six wide along the backstretch, edged closer from outside on the turn, made a run to challenge entering the stretch, surged to the front in upper stretch, ducked in when tapped right handed nearing the furlong marker then drew clear under steady right hand encouragement. BLAZING SWORD ducked out after breaking a bit slowly, trailed along the backstretch, circled seven wide to launch his bid on the turn and finished well in the middle of the track. WITH ANTICIPATION sprinted clear in the early stages, set a pressured pace along the rail to the turn and weakened in the drive. KARLY'S HARLEY pressed the early pace outside WITH ANTICIPATION along the backstretch, gained a slim lead on the turn, battled along the inside entering the stretch, steadied sharply inside LEMON DROP KID nearing the eighth pole and failed to threaten thereafter. Following a stewards inquiry into the stretch run along with a claim of foul by the rider of KARLY'S HARLEY, LEMON DROP KID was disqualified from first and placed fourth for interference in the stretch.
