**Footnotes**

EIGHTH AVENUE unhurried early, swung out for the stretch run, rallied to take over at the sixteenth pole and won going away. JAMBONIED set the pace under pressure along the rail, opened a clear lead in midstretch but couldn't match strides with the winner late while clearly second best. ROARING CONQUEST allowed to settle, saved ground around the turn and closed to gain the show. MAKING TRACKS chased the pace along the inside, eased out for the stretch run, then was steadied to avoid running up on SELECT FOR MONEY inside the eighth pole and failed to recover. SELECT FOR MONEY pressed the pace outside JAMBONIED to the top of the stretch, then tired. GRANGERARDO tracked the pace, angled four wide on the turn, then faltered in the drive. POSITIVE ACTION was not a factor. UP IN SMOKE chased the pace three wide to midway of the turn, then faded.
