Footnotes

ANUNCIATA (PER) set the pace along the inside, came out a bit for the stretch run, then responded when challenged by MELODY DAWN through the final eighth and held on gamely to prevail. MELODY DAWN stalked the pace along the rail, made a run to try ANUNCIATA through the final eighth but couldn't get by that rival. TEAM stalked the pace off the rail, eased out for the stretch run and was gaining on the top ones at the finish. AFFAIR DABBLER reserved off the pace, raced four wide around the far turn, rallied to loom a threat at the eighth pole but couldn't sustain her bid. INIMITABLE ROMANEE allowed to settle, saved ground and finished willingly in behind rivals. IMPERIAL PIPPIN hit the gate at the start, rushed up down the backstretch to chase the pace three wide into the stretch, then weakened. FOREST LEGEND up close early, eased back around the first turn, swung out for the stretch run and lacked a rally. NANDIRA steadied from tight quarters on the first turn and failed to menace. CHRISTINA D'ORO was not a factor. WET ONE (IRE) chased the pace into the stretch and gave way. PINK PALACE was outrun. WAQUOIT'S DANCE unhurried early, swung wide while moving up a bit leaving the far turn, then tired.
