**Footnotes**

PROSPECTOR'S BRIDE chased the pace three wide, moved to gain a slim lead on the turn, responded when challenged by IZTLA at the top of the stretch and edged that rival to the wire after a stretch long duel. IZTLA reserved early, rallied along the rail to reach even terms for command at the top of the stretch, then dueled with PROSPECTOR'S BRIDE to the wire and just missed. I'M A CAUTION chased the pace four wide, made a run at the lead around the turn, then tired. KELLY K'S PLEASURE rated off the pace, raced three wide on the turn and had no response when asked. SALTSTER showed speed off the rail to nearing the stretch, then faltered. PERSONAL ODYSSEY failed to menace. MY LILIANA was outrun after being steadied at the start.
