Footnotes

ZORAN stalked the pace along the rail, angled out for the stretch run, rallied to catch STAGE DELI at the eighth pole, then drew away under urging. WINAWAY unhurried while saving ground, swung out for the stretch run and closed to gain the place. STAGE DELI chased the pace three wide, rallied to take over at the quarter pole, made the pace to nearing the eighth pole, then gave way. GREAT BLADE reserved racing along the inside, angled out for the stretch run and improved his position. JILLUKE rated off the pace, advanced four wide around the turn to loom a threat in the stretch, then flattened out. UNBRIDLED'S GUN tracked the pace into the stretch and tired. YOMBO MAUGERE raced three wide and failed to menace. INTERCOASTAL showed speed along the rail to nearing the quarter pole, then faltered. QUICK APPEAL reserved off the pace, raced three wide around the turn and faded. RAGING

TRIPP was done early. PUT IT BACK TWENTY pressed the pace to midway of the turn, then had nothing left. BROWN'S HILL off slowly, trailed.
