**Footnotes**

MIDNIGHT NOTES stalked the pace, angled outside the leaders leaving the far turn, rallied to gain the lead at the sixteenth pole, then was all out to prevail. SPIVEY stalked the pace along the rail, slipped through inside ARION SILVER to reach even terms for command at the sixteenth pole but was outgamed to the wire. ARION SILVER set the pace along the inside, came out a bit for the stretch run while maintaining his advantage to the sixteenth pole, then weakened. ACT OF MADNESS prompted the pace outside ARION SILVER to nearing the top of the stretch, then tired. SCOTFIELD failed to menace. OVER AND BACK rated off the pace, raced three wide around the far turn and faltered. EL CHUVASCO was no factor after being steadied from between rivals on the first turn. GOLD MATE stalked the pace three wide, then drifted out at the top of the stretch and faded.
