Footnotes

AMERIHEART set the pace three wide, bumped repeatedly with CONVOY BOY in early stretch, then was all out to just last over TAPITBOUND. The latter, reserved after being steadied in the chute, swung out for the stretch run and rallied to just miss. BIG BAD BLUE unhurried early, rallied three wide to loom a threat in the stretch but couldn't sustain his bid. TRANSLUCENT SKY tracked the pace five wide, rallied to reach the leaders leaving the turn, then bumped repeatedly with CONVOY BOY in the stretch and gave way. CONVOY BOY prompted the pace outside AMERIHEART, then was bounced around between rivals approaching the eighth pole, then tired. STARGLEAM failed to menace. SINFULL LOVE was not a factor. UNBRIDLED FUTURE chased the pace

into the turn and faltered. MORGANS BOY saved ground and faded. PENALTY KICK was done early. BRONX BULL chased the pace into the turn, then had nothing left. There was a stewards inquiry into the bumping incident in the stretch. No action was taken.
