Footnotes

FULL IN unhurried early, angled to the outside for the stretch run, then rallied under a strong hand ride to take over at the sixteenth pole and won going away. JET PROPULSION set the pace along the rail, increased his advantage in the stretch but was no match for the winner late while clearly best of the others. PE DE CHUMBO tracked the pace three wide into the stretch and tired. DANCING IN GERARDA off slowly, failed to menace. LITTLE RESPONSE prompted the pace outside JET PROPULSION into the far turn, then faltered. THE BUSINESS MAN was not a factor. HAPPY EXPLOIT well placed while saving ground into the stretch, faded.
