Footnotes

ON APPEAL rated off the pace, raced three wide around the turn, rallied to take over nearing the eighth pole, then edged away under urging. DOUBLE JUDGE showed speed off the rail into the stretch, then couldn't stay with the winner while saving the place. POT OF GOLD outrun early, swung wide for the stretch run and closed well to just miss the place. NO ACT reserved off the pace, angled out for the stretch run and closed with a belated rally. BURNING MANDATE allowed to settle, raced four wide around the turn and closed with a mild response. WILD ALLEY CAT stalked the leaders off the rail around the turn, then weakened. B L'S A RUNNER stalked the pace three wide to midway of the turn and tired. COVER PRICE raced three wide and failed to menace. LONGER TERMS DOUG was not a factor. STORMIN WILDCAT chased the pace along the inside to the top of the stretch, faltered. QUICK CODE off slowly, was outrun. ZIP IT NANCE saved ground and faded.
