SAN DARE reserved after hitting the gate at the start, raced off the rail, split rivals while rallying on the far turn and closed to prove second best while unable to stay with the winner. HI TECH HONEYCOMB rated off the pace, made a run three wide on the final turn to reach the attending position, then tired in the drive. SPICE ISLAND chased the pace along the inside into the stretch and faltered. FLYING MARLIN was not a factor. AMELIA quickly sprinted to a clear lead, made the pace along the inside into the final turn and faded. QUEUE trailed.
