SINGAPORE THUNDER unhurried after being steadied when bumped soundly by OH NO THE ALARM in the early going, saved ground into the stretch, angled wide to get outside the leaders in the stretch, then rallied to be up late. RINUNCIO BOBO rated off the pace, eased four wide racing into the stretch, rallied to gain a slim lead nearing the sixteenth pole but couldn't resist the winner late. WINONEFORTHEZIPPER vied for the lead between horses to nearing the sixteenth pole, then weakened. GAL HAS TO LIKE IT vied for the lead three wide to nearing the sixteenth pole and gave way. D' NEXT EXPERIENCE chased the leaders four wide into the stretch, then tired. HEY BRAYDEN failed to menace. OH NO THE ALARM steadied when he bumped hard with SINGAPORE THUNDER in the early going and was not a factor. MY PEOPLE vied for the lead along the inside into the stretch, then faltered.
