CARRIED INTEREST vied for the lead along the inside to deep stretch but was outgamed to the wire. DEFEND was caught in tight at the start, stalked the pace three wide into the stretch, then gave way. MOVE OVER failed to menace. CAT FIVE HURRICANE chased the pace off the rail around the turn, then tired. CAPITAL CITY reserved racing along the inside, steadied on the backstretch and faltered. JOHN GORDON was done early.
