COMPRISE reserved racing along the rail, slipped through inside OPEN SLEIGH on the turn, rallied to catch TRYING BRIAN nearing the eighth pole, then was under steady pressure to hold that rival off. TRYING BRIAN vied for the lead outside OPEN SLEIGH, edged away from that one approaching the quarter pole, then responded after losing the lead to COMPRISE and continued on gamely while being edged to the wire. ZAMBEZI WARRIOR steadied in the early going, chased the pace into the stretch but didn't do enough late. WINSTRELLA chased the pace three wide, was outmoved by the top ones leaving the turn, then was gaining on those rivals late. DRAGON FI unhurried early, advanced along the rail to reach contention in the stretch, then tired. OPEN SLEIGH vied for the lead off the rail to past midway of the turn, then faltered. GAME INFORMER tracked the pace four wide to nearing the stretch, then faded. RED HOT POKER steadied in behind rivals on the backstretch and was through after a half mile. ANDOLINI was no factor after hesitating at the start. JUDGE HENRY FERRO hesitated at the start and was outrun. OURTIMETODANCE trailed after breaking poorly.
