Footnotes

CELESTIAL WOODS set the pace along the rail, repulsed a bid from TIZLATER leaving the far turn, then increased her margin to the wire under a hand ride. TIZLATER never far back racing along the rail, eased out and made a run at the winner racing into the stretch but couldn't stay with that rival while proving second best. TIFFANY TWISTED rated off the pace after bumping with DIXIE PARADISE at the start, was racing three wide when forced to steady in behind the stopping HEAVENLY BLUES on the far turn, angled to the inside for room and closed to gain the show. DEJA ENTENDU reserved along the inside, steadied to avoid running up on a rival on the far turn, remained in contention into the stretch, then had no response when asked. BREAK THE BANK chased the pace to nearing the stretch, then tired. DORYPHAR failed to menace. ARCHSTONE allowed to settle, raced four wide on the far turn and lacked a rally. PINE SHELTER raced in striking position three wide around the far turn and faltered. DIXIE PARADISE was no factor after bumping with TIFFANY TWISTED at the start. AUNTIE BOO saved ground to no avail. OCEAN SOUND raced three wide and faded. HEAVENLY BLUES chased the pace three wide to midway of the far turn, then stopped.
