Footnotes

MAGIC MESA set the pace under pressure along the rail, edged away in midstretch, then just lasted over RUNWAY READY. The latter, chased the pace, eased three wide leaving the turn, was bothered by SHENTON PARK in early stretch, then rallied to just miss. CALL MY LAWYER off slowly, was unhurried early, raced three wide around the turn, then rallied for the show. SHENTON PARK pressed the pace outside MAGIC MESA, drifted out a bit bothering RUNWAY READY in early stretch and gave way. WILD ORATION failed to menace. DREAMINOF CARMELA C was not a factor. COMMENCE FIRING saved ground and tired.
