SNEAKY STEPHEN vied for the lead three wide, continued to contest the pace with CAIXA ELETRONICA from midway of the turn to the sixteenth pole, then edged away. CAIXA ELETRONICA vied for the lead along the inside to the sixteenth pole, then weakened. VEER tracked the pace three wide around the turn, angled out for the drive and had no late response. FROSTLY KNIGHT vied for the lead between horses to midway of the turn, then faltered. SPICY VOW well placed early, faded.
