**Footnotes**

BAY POINT COUNTESS reserved racing along the inside, angled three wide for racing room on the far turn, rallied to take over at the top of the stretch, then was all out to prevail. HOT CAT allowed to settle, rallied along the rail to reach the attending position in the stretch but couldn't gain on the winner late. MANDATED TO WIN unhurried early, raced five wide around the far turn to loom a threat in midstretch, then flattened out and was edged for the place. HARLEM PRINCESS outrun early, circled rivals five wide around the far turn, came out widest of all for the stretch run and was gaining at the finish. BUTTERDISH stalked the pace, was attempting to move up when steadied from close quarters in the stretch and gave way. LOITA came through tight quarters along the rail entering the first turn to gain the lead, came out on the backstretch to make the pace racing off the rail to the top of the stretch, then weakened. JUST A DREAM chased the pace from the outside, raced five wide around the far turn and tired. ROAR OF THE KITTY stalked the pace, made a run four wide to join the leaders on the far turn, then faltered in the drive. STORMIN BON was through after a half mile. ROSSI'S GIRL failed to menace.

LOVEOFMYALY was not a factor. FUZZY GUT GIRL chased the pace, was steadied and angled to the rail on the backstretch, continued to chase the pace to the quarter pole, then faded and eased in the final eighth.
