Footnotes

DANNY'S FRIEND off slowly, tracked the pace, angled three wide leaving the turn, rallied to reach even terms for command with CHEROKEE CHAMPION inside the eighth pole, then vied with that rival to deep stretch and prevailed. CHEROKEE CHAMPION chased the pace off the rail, rallied to reach even terms for command just inside the eighth pole, then vied with DANNY'S FRIEND to deep stretch and was outgamed to the wire. COUNTRY GREEN allowed to settle, advanced off the rail to loom a threat in midstretch but couldn't gain late. CUGATCHA set the pace along the inside to past the eighth pole, then gave way. KAWIYE reserved off the pace, advanced along the inside to reach contention in the stretch, then flattened out. SILVER CHEST steadied soon after the start and failed to menace. JAZZY MOVES tracked the pace three wide to the quarter pole, then tired. TOGETHER FOREVER broke slowly, raced four wide around the turn and faltered. GLITZY GLIDER trailed.
