DYNAMIC BOY quickly sprinted to a clear lead along the rail, made the pace into the stretch, then was fully extended to hold sway. RUNYON HUMOR reserved after clipping heels soon after the start, rallied three wide around the far turn to loom a threat but couldn't get to the winner while continuing on with good courage to prove second best. DREAMING OF DANNY tracked the pace, eased outside the leaders leaving the far turn and had no response when asked. THE B'S AND E'S unhurried early, swung out for the stretch run and passed tired rivals without threatening. ALKE JOHN rated off the pace, was advancing along the rail when he bumped with SKY MASTERSON leaving the far turn, steadied and tired. DON'T SAY NO failed to menace. SKY MASTERSON chased the pace off the rail, then was steadied when he bumped with ALKE JOHN leaving the far turn and faltered. HOLD THAT CAMERA allowed to settle, swung wide for the stretch run and was not a factor.
