HANALEI allowed to settle, rallied four wide around the far turn to take over entering the stretch and opened a clear lead, then was fully extended to prevail. RARO tracked the pace, bumped with STORIED in the stretch, then rallied for the place. KATE MANDY unhurried after being steadied at the start, swung out for the stretch run and closed to be up for the show while no threat to the top ones. STORIED reserved off the pace, made a run three wide around the far turn to reach contention leaving the far turn, then bumped with RARO in the stretch and gave way. WILD HORSE ANNIE outrun early, steadied to avoid running up on a rival in the stretch and failed to menace. CAUSE I'M CLASSY was not a factor. BELLATARA steadied in the early going, tracked the pace three wide, moved to take over on the far turn, made the pace to nearing the top of the stretch, then tired. NATALIE'S GOAL chased the pace, made a run to reach near even terms for command racing into the stretch, then faltered. LIZZIE BEAR bumped with FABULOUS SASHA on the first turn while showing

brief speed, chased the leaders along the inside to the far turn, then faded. JABEZ prompted the pace outside FABULOUS SASHA into the far turn, then had nothing left. FABULOUS SASHA bumped with LIZZIE BEAR on the first turn while showing speed outside that rival, moved to the inside racing down the backstretch while making the pace into the far turn, then stopped.
