WILDCAT LILY chased the pace three wide, moved up to engage LOVE TRAIN racing into the stretch, then brushed with that rival while dueling through the stretch and prevailed. LOVE TRAIN pressed the pace, moved to gain a slim lead on the turn, responded when challenged by WILDCAT LILY entering the stretch, then came out a bit brushing with that rival while dueling for the lead and just missed. LUCKY LIBERTY rated off the pace, raced four wide around the turn and closed with a mild response to gain the show. UNABASHED was racing with the leaders when taken up from tight quarters entering the turn and failed to recover. SILVER SASHAY pressed the early pace along the rail and tired. R NEXT ESCAPADE showed speed outside SILVER SASHAY, eased to the inside on the turn when that one dropped back, then faltered after losing the lead nearing the quarter pole. THE RIDER OF LOVE TRAIN LODGED AN OBJECTION AGAINST THE RIDER OF WILDCAT LILY FOR INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
