### Footnotes

SIMMARD under stout restraint for more than a mile, eased outside SPORTY for racing room in the stretch, then rallied under a strong hand ride to be up late. EN FUEGO unhurried for more than a mile, swung out for room on the far turn, rallied quickly to gain the lead in the stretch but couldn't resist the winner late. SPORTY set the pace along the rail into the stretch the final time, then gave way. MR.UNIVERSO (BRZ) stalked the pace, made a run to try SPORTY at the quarter pole, then tired in the drive. BIGSHOT tracked the pace along the rail into the final turn and faltered. FREE FIGHTER tracked the pace three wide into the final turn, then faded.
