ZA APPROVAL rated off the pace, swung out for the stretch run, then rallied to be up in time. KANAGARO stalked the pace, eased out and rallied to gain the lead inside the eighth pole, then just failed to last. EXCLUSIVE STRIKE reserved along the inside, advanced around the far turn, then steadied when caught in behind the incident nearing the eighth pole, recovered and finished willingly to be up for the show. GUY ON THE GO chased the pace, moved to gain a slim lead in early stretch, then came in impeding CONCORDE EXPRESS approaching the eighth pole and gave way. RIVER LEMON unhurried after being pinched back in the early going, improved his position in the drive without threatening. NINE O WONDERFUL allowed to settle after breaking slowly, circled rivals four wide around the far turn to loom a threat in the stretch, then tired. GREAT SCOT stalked the pace, made a run three wide around the far turn to reach contention entering the stretch, then faltered. CONCORDE EXPRESS set the pace along the rail, responded when GUY ON THE GO gained the advantage, then was taken up when that rival came in on him nearing the eighth pole and dropped back. ET AL broke in the air, saved ground and failed to menace. GET A GRIP (IRE) was outrun. FOLLOWING A STEWARDS INQUIRY, GUY ON THE GO WAS DISQUALIFIED AND PLACED EIGHTH FOR INTERFERENCE TO CONCORDE EXPRESS IN THE STRETCH.
