STAKES Secret Grace S. Black Type - Thoroughbred

FOR FILLIES THREE YEARS OLD. Free nomination by Wednesday, March 23, 2013, \$100 to pass the entry box and \$300 additional to start, with \$55,000 guaranteed and an additional \$15,000 FOA. All fees shall be paid prior to the start of the race. The owner of the winner to receive 60%, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Supplemental nominations may be made at time of entry at a fee of \$800, which includes entry and starting fees. Weight: 122 lbs. Non-winners of a graded stakes on the turf allowed 2 lbs.; a sweepstakes at a mile or over, 4 lbs., two races other than maiden or claiming 6 lbs. Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 starters, with also eligibles. If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners then highest career earnings. Trophy to the winning owner. Nominations Closed Saturday, March 23, 2013 with 24 Nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile).

SWEAR ME IN showed early speed along the inside, was outmoved down the backstretch, angled out bothering COARSEGOLD on the far turn, rallied to gain the lead inside the eighth pole, then was fully extended to prevail. COARSEGOLD saved ground after being steadied in the early going, eased out on the far turn, was moving into contention when steadied and forced to swing out in behind SWEAR ME IN leaving the far turn, then finished willingly for the place. COFFEE CLIQUE allowed to settle, was moving into contention when forced wide leaving the far turn, then rallied for the show. STREET GEM chased the pace off the rail, moved to take over racing down the backstretch, made the pace off the rail to inside the eighth pole, then gave way. WITH SUGAR ON TOP stalked the pace three wide, then was tiring when forced out leaving the far turn. FAB FLOWERS stalked the pace four wide into the far turn, then was fading when forced very wide leaving that turn. WHOLELOTAROYALTY showed early foot and faltered. FOLLOWING OBJECTIONS BY THE RIDERS OF COARSEGOLD AND COFFEE CLIQUE, SWEAR ME IN WAS DISQUALIFIED AND PLACED THIRD FOR INTERFERENCE TO THOSE RIVALS LEAVING THE FAR TURN.
