DREAM MAESTRO rated off the pace, rallied three wide around the far turn to reach even terms for command at the top of the stretch, then brushed with DA' TARA while dueling with that rival and prevailed. DA' TARA stalked the pace, moved up to reach even terms for command entering the stretch, then brushed with DREAM MAESTRO while dueling with that one through the stretch and was edged to the wire. FANCY RUNNER tracked the pace into the stretch and lacked a late response. TOO GOOD failed to menace. B. B. BEST drifted out on the first turn while setting the pace, was angled back in to make the pace to nearing the top of the stretch, then tired. PREMIUM GOLD tracked the pace into the far turn and faltered. COACH SHAW was outrun. The rider of DA' TARA lodged an objection against the rider of DREAM MAESTRO for alleged interference in the stretch. The claim of foul was not allowed.
