SCHOPENHAUER stalked the pace along the rail, slipped through inside GREY BOUNDARY in the stretch to gain the lead, then edged away. GREY BOUNDARY set the pace along the inside, came out a bit for the stretch run and couldn't resist the winner while continuing on with good courage for the place. BLAZEN stalked the pace into the stretch and had no late response. ARMSTRONG MILL stalked the pace three wide into the stretch and lacked a rally. NACHO CORONA stalked the pace into the stretch, then weakened. CAT 'N FIDDLE hesitated at the start, saved ground and failed to menace. STORMY MIRAGE rated off the pace after stumbling at the start, steadied when caught in tight entering the far turn and tired.
