Footnotes

FISHERMAN'S WHARF reserved off the pace, advanced into contention off the rail around the turn, angled outside the leaders for the stretch run, then rallied to gain the lead at the sixteenth pole and drew clear. GOLDEN WEEKEND pressed the pace outside UNDER CONTRACT to inside the eighth pole, then continued on with good courage to gain the place while being outfinished by the winner. LIVIN LARGE outrun early, swung wide for the stretch run and rallied to be up for the show. FOLLIA allowed to settle, passed tired rivals in the drive while being edged for the show. MOOSE MAN chased the pace off the rail, angled out for the stretch run and weakened. UNDER CONTRACT set the pace under pressure along the rail to the sixteenth pole, then gave way. MATT'S A GIANT rated off the pace, raced four wide around the turn, swung out for the stretch run and never threatened. RIGHT OF WAY chased the pace three wide around the turn and tired. DEPUTY DANCE well placed while saving ground, faltered in the drive. MORALITY off a step slowly, saved ground around the turn and was not a factor.
