VALID stalked the pace three wide, assumed command on the turn dueled into the stretch and drew off under urging. ACTION ANDY set the pace saving ground into the turn, dueled into the stretch and gave way. SILVER MENACE with the pace off the rail, weakened. REGULUS broke slowly, chased the pace saving ground then tired. MANAGED ACCOUNT prompted the pace three wide then faded. SMALL TOKEN trailed.
