### Footnotes

THUNDER PASS stalked the pace, raced four wide around the far turn, rallied to take over in deep stretch, then was fully extended to last over WESTMORELAND. The latter, outrun early, swung out for the stretch run and finished full of run to just miss. SOMES SOUND set the pace racing just off the rail, responded when RUNNING WISH moved to the lead in the stretch and continued on with good courage to save the show while being outfinished by the top ones. COLORFUL JUDGEMENT unhurried early, angled out in the stretch and closed well to just miss the show. RUNNING WISH chased the pace

along the rail, slipped through inside SOMES SOUND to gain the lead nearing the eighth pole, made the pace to deep stretch and gave way. FLEET APPEAL failed to menace. REAL QUALITY outrun early, rallied three wide around the far turn to loom a threat in midstretch but couldn't sustain his bid. UNGI BLANC rated off the pace after breaking poorly, advanced to reach contention racing into the stretch, then tired. FOREIGN RUCKUS reserved racing along the rail, had no response when asked. LION MAN saved ground to no avail. STRIKE IMPACT raced in contention four wide into the far turn, then faltered. A FLEET PROSPECTOR chased the pace, then was fading when checked leaving the far turn.
