RANSOM DUE stalked the pace, advanced along the rail on the far turn, eased outside KIT CAT CATON, bumped with that rival while rallying to gain the lead at the sixteenth pole and prevailed. SMOOTH BREW allowed to settle, steadied when trapped in behind rivals on the far turn, angled out for the drive and rallied to be up for the place. KIT CAT CATON chased the pace, moved quickly to take over on the far turn and opened a clear lead, then was being outfinished when she bumped with RANSOM DUE, then steadied inside that rival late. TIA DIA unhurried early, raced four wide on the far turn and closed with a belated rally. CREME DE MENTHE outrun early, advanced along the rail to loom a threat in midstretch, then flattened out. FORTUNA stalked the pace three wide, made a run to join the leaders on the far turn, then gave way. BANK ON SILVER off slowly, failed to menace. ACE KICKER was no factor

while racing three wide. CAROLINA TRIPPER set the pace into the far turn, then tired. DOUBLE OR QUILTS steadied in traffic on the first turn and again on the backstretch, then faltered. EUROPIUM was through after six furlongs. SWEET VALENTINE was done early. The rider of KIT CAT CATON lodged an objection against the rider of RANSOM DUE for alleged interference in the final sixteenth. The claim of foul was not allowed.
