ROCKING OUT outrun after breaking slowly, swung out for the stretch run, then rallied to gain the lead at the sixteenth pole and won going away. GOLD FOR CASH tracked the pace, rallied three wide to reach even terms for command with DUAL EXHAUZZT midway of the turn, then dueled with that rival to the sixteenth pole and was outfinished. DUAL EXHAUZZT showed speed along the inside, responded when challenged by GOLD FOR CASH on the turn, then dueled with that rival to the sixteenth pole and weakened. FINANCIAL EMPIRE unhurried early, veered out sharply at the top of the stretch, then closed with a mild response. BAIL OUT THE CAT chased the pace into the turn and tired. VALUE ADDED TAX rank in the early going while being rated off the pace, raced three wide around the turn and faltered. IMPERSONATOR tracked the pace along the rail to midway of the turn, then faded.
