Footnotes

KIT CAT CATON rated back inside, rallied on the rail into the stretch and drew clear past the sixteenth pole. MASTER TRICKY rated close to the pace inside, angled out making contact with Judge's Pride near the three sixteenths pole, was carried out from there while dueling for place then bumped in deep stretch. BELIEVEINTHEMOMENT chased the pace about the three path, checked at the flanks of Judge's Pride approaching the turn, continued her efforts through the turn then finished evenly. LUCKY LIZA rated the pace inside, lost ground leaving the turn, continued drifting outward through the lane and made contact with Master Tricky in deep stretch. SILVER ASHLEE lacked room early, saved ground through the turn, eased out into the stretch and finished well. JUDGE'S PRIDE chased the pace toward mid track, was bumped out near the three sixteenths pole and weakened from there. INDY CATE steadied early, closed toward contention outside then leveled off through the lane. LAURA'S LUCK faded steadily. JAZZ HER UP chased the pace while off the rail then

weakened. HAROLDS SISTER chased the pace in mid track and weakened through the lane. THREE HAIL MARYS never factored while saving ground. The stewards posted the inquiry and disqualified Master Tricky to sixth for having interfered with Judge's Pride in the vicinity of the three sixteenths pole.
