**Footnotes**

PRIMARY WITNESS rated just off the pace inside, started his drive off the rail leaving the five sixteenths pole, made light contact with Glittermans Cartel at the top of the stretch then drew off the final sixteenth. CINNAMON ROAD came in early, rated clear inside, was pressured past the quarter pole and remained a close factor to midstretch before ceding. GLITTERMANS CARTEL, kept in range off the rail, gave chase into the final turn, was brushed lightly at the top of the stretch and leveled off from there. SINCERO, forced in early, gave chase about the three path but showed no response on the turn. SAN VALENTINO was forced in early then never factored. DISGUISE, forced in early, showed no speed outside. TEXAS HEDGE was forced in early and never factored.
