Footnotes

CHISTOSA showed speed off the rail, responded when challenged by DIARY leaving the turn, then brushed with that rival while dueling for the lead and prevailed. DIARY chased the pace four wide, made a run to reach even terms for command with CHISTOSA leaving the turn, then brushed with that rival while vying for the lead in the stretch and was outgamed to the wire. REPUBLICAN pressed the pace three wide to the quarter pole, then bore out through the stretch while tiring. SHE BE CLASSY well placed racing along the rail, faltered in the drive. SCREEN LEGEND broke a step slowly, then was no factor while racing four wide. SUCCESSFUL SONG stumbled at the start, tracked the leaders to midway of the turn, then faded. DETERRENCE chased the leaders three wide into the turn, then had nothing left. The rider of DIARY lodged an objection against the rider of CHISTOSA for alleged interference in the stretch. The claim of foul was not allowed.
