**Footnotes**

PULSION showed speed off the rail, edged away in the stretch, then was fully extended to maintain his advantage to the wire. LEAVENWORTH stalked the pace into the stretch but couldn't gain late while up for the place. STAR PLAYER pressed the pace three wide into the stretch, then weakened. NUMB LIPS reserved early, advanced five wide around the turn to loom a threat, then flattened out. SKY VENTURE tracked the pace four wide, then couldn't keep pace in the drive. CINNAMON ROAD showed speed along the rail into the turn and tired. MOTIN was not a factor. SONG CYCLE tracked the pace to nearing the stretch, then faltered.
