GREEN MONSTER rated back off the rail, angled widest making his bid from the five sixteenths pole then gained slowly to get up nearing the wire. TELLUM BERTO chased the early pace from the inside, angled five wide past the five sixteenths pole, dueled for the lead in the upper stretch then drifted in and was outfinished nearing the wire. CAPITOL APPEAL, jostled at the start, saved ground off the pace, bid two deep on the turn, came toward the inside entering the stretch, had aim a furlong away, was shuffled back at the sixteenth pole, eased out from there and finished well. CHRISTOPHER'SIMAGE, slow into stride, showed no speed while saving ground and finished evenly. CLOSING HOUR chased the pace inside, eased off the rail taking aim into the turn and dueled close to midstretch before giving way. HE'S EXPLOSIVE was outrun. TRUMPETER AL moved to the lead while drawing clear approaching the turn then faded from the head of the lane. The stewards reviewed a claim of foul against the rider of the runner-up, lodged by the rider of third place finisher, Capitol Appeal though found no cause to make a change.
