Footnotes

J'S SUNDANCE HALO bobbled a stride from the gate, rated the pace at the rail, was pressured from the top of the stretch, edged briefly clear a furlong away and lasted well under a stout drive. BLACK SCORPION rated back off the rail, lacked room at the heels of Nineinthenine into the final turn, eased five wide through the turn, came between horses midstretch to make his bid, finished well and was gaining. UNBRIDLED HEAT, off the pace inside, was boxed at the rail the final turn, came through a small opening at the top of the stretch, took aim a furlong away and finished well while outfinished late for place. BLAZEN rated off the pace outside, came through the final turn six wide then leveled off from the eighth pole. WINGEDLIE rated off the pace toward mid track, came through the final turn five wide then lost momentum while in tight nearing the wire. EXCELLENT SOLDIER rated back toward the inside, was blocked at the heels of Unbridled Heat entering the stretch and lacked further response. RAYBERN'S GOLD stalked the pace off the rail, took aim three wide through the final turn but proved empty in the drive. NINEINTHENINE rated off the pace two deep while between horses and gave way through the lane.
