PAIZANO, bumped at the start, was well reserved to set the pace off the rail, edged away through the turn, kept awake in the upper stretch and widened steadily. BERNIE THE MAESTRO rated off the pace four wide, started his drive past the three eighths pole and dueled for place while no match for the winner. CONCORDE'S FURY showed no early speed inside, eased out through the turn, entered the stretch four wide then outfinished in the duel for place. FORWARD OBSERVER, off the pace outside, started a five wide drive into the turn then leveled off in the stretch. AIROFINDIFFERENCE showed no speed while saving ground. HONOR IN PEACE broke inward making contact with Paizano and chased that one to the quarter pole before giving way. RICHIE RULES and GESU were not factors. MY CHARMING CLYDE chased the pace inside, showed no response through the turn and gave way nearing the quarter pole.
