ROMACACA steadied from between rivals at the start, was rank and steadied several times while restrained in behind the leaders, stalked the pace into the stretch, angled out for room after being steadied again in behind rivals in early stretch, then rallied under a strong hand ride to be up late. TRIP FOR A. J. stalked the pace three wide, moved to take over inside the eighth pole but couldn't resist the winner late. ROMIN ROBIN rated off the pace, advanced four wide down the backstretch and around the far turn to loom a threat, then gave way in the drive. DREAMED TO DREAM prompted the pace outside GRANTED TIGER, gained a slim lead from that rival leaving the far turn, maintained that advantage to inside the eighth pole, then tired. DANCING RAGE off slowly, failed to menace. GRANTED TIGER set the pace along the rail to past midway of the far turn, then faltered.
