### Footnotes

HEIKO was away alertly to set a pressured pace from the inside, opened a clear margin into the lane and raced in hand through the final furlong. COZY KITTEN was never far back while racing from between rivals, moved outside through the second turn and finished with good late energy. BLAMESHIFTER was allowed to settle in stride early, circled the field for a striking position nearing the quarter and failed to sustain his bid in the drive. HOUNGUN chased the leaders from the inside and gradually gave way in the drive. MY D'ORO pressed the pace of the winner from the outside for six furlongs and gave way. CHUFFED TO BITS lacked early speed, raced wide through the second turn and did not threaten. LANCE STUNNING showed no early foot, saved ground through the second turn, angled out into the stretch and did not menace. SKY MASTERSON also showed no early speed, raced far wide through the second turn and was not a factor.
