Footnotes

STADION tracked the speed on the inside, angled in for the drive, slipped through and prevailed under urging. CANTINERO in good position, rallied to be up for the place. TODGE well placed, rallied mildly to gain the show. MECKE MANTLE set the pace along the inside into the stretch, bore out impeding rivals and gave way. FULL RIDE allowed to settle, rallied into the stretch and weakened. FILM STAR stalked the pace off the rail steadied in the stretch when rival bore out and tired. HAYATI SON circled the field three wide to reach contention nearing the quarter pole, was steadied in tight in the drive and faded. FEEL MY THUNDER raced up close and faltered. FORTISSIO tracked the speed into the final turn, checked in traffic and stopped. FOLLOWING A STEWARDS INQUIRY AND A RIDERS CLAIM OF FOUL, MECKE MANTLE WAS DISQUALIFIED FROM FOURTH AND PLACED SEVENTH FOR INTERFERENCE TO BOTH FILM STAR AND HYATI SON IN THE STRETCH. ALSO, THE RIDER OF FORTISSIO CLAIMED FOUL AGAINST THE JOCKEY ON HYATI SON FOR ALLEGED INTERFERENCE ON THE TURN. THE CLAIM WAS DISALLOWED.
