**Footnotes**

TOH'S GREY CAT unhurried early, swung out for the stretch run, rallied to catch BLANDISHING at the sixteenth pole, then drew away. BLANDISHING vied for the lead three wide to nearing the turn, opened a clear lead while easing to the inside on the turn, made the pace to the sixteenth pole but was no match for the winner. I CAN AND I WILL reserved off the pace, raced four wide around the turn and closed to gain the show. TIGER DISTINCTION tracked the leaders three wide, moved into the attending position approaching the quarter pole, then tired in the drive. SAILING CLEAR vied for the early lead between horses, chased BLANDISHING around the turn, then faltered in the drive. R PAYNES PRINCE vied for the early lead along the rail and faded. RUNNING WILDCAT was through early.
