MEAN SAX led throughout saving ground and prevailed under pressure when challenged late. MONROE COURT stalked the pace three wide then rallied to just miss. DINNER IN ODEM stalked the pace along the inside and gave way. GIBSON COUNTY LINE pressed the pace off the rail and weakened. EL ROMANO allowed to settle and rallied mildly. HUGO LIGHT tracked the speed and faded. VANQUISHER chased the speed three wide and tired. KID CURRY allowed to settle, lacked the needed late response. RECHARGED raced up close off the rail then faltered. AUDACITY OF HOPE (GB) raced with the speed three wide and stopped. WINNER JAK showed little. MR. MONARCH trailed, lost contact with the field and was eased.
