Footnotes

CARAQUISTA was slow early, raced four wide in the stretch and surged late to get up in time under strong encouragement. THREE HEARTS stalked the pace, moved up four wide through the far turn, led deep stretch and just missed in a game effort. GO KITTEN GO was bumped at the start, raced three deep in the stretch and finished willingly to the wire. TIE DYE was allowed to settle early, moved up four wide into the upper stretch and had no late winning bid. SENSATIONAL APPEAL raced in a bit tight at the start, raced three deep and had no final bid. ROSIE RED showed good speed and weakened while racing along the inside. I KNOW IT ALL was slow early, raced six wide into the upper stretch and never menaced. SPECTACULAR ME failed to sustain a bid. SHRINKING VIOLET stalked the pace, checked sharply at the eighth pole and tired thereafter. BELIEVE IN CHARLIE stalked the pace from the outside and tired.
